

HANDGUN MAGAZINE SHIPPING RESTRICTIONS

Cajun Gun Works, LLC complies with all, Federal, State, and Local laws regarding magazine capacity. However, we may not be aware of every state and or local ordinance. Due to the ever-changing state and local regulations, it is the **buyer's responsibility** to know their state and local laws. The following information should be viewed solely as guidance, NOT legal advice. You are responsible for ensuring compliance with state and local firearms regulations when completing a purchase.

Ultimately it is the buyer's responsibility to know their local and state laws regarding magazine capacity. Orders placed for magazines that are illegal in your locality are subject to cancellation and a restocking fee of 15% (to cover the cost of the transaction and credit card processing fees). Please do not knowingly order magazines that are illegal in your state/ locality.

This is a list of handgun magazine capacity restrictions by state or locality that we are currently aware of:

CALIFORNIA CUSTOMERS: No magazines over 10 rounds. We are restricted from shipping magazines with a capacity exceeding 10 rounds to customers with a California shipping and/or billing address.

COLORADO CUSTOMERS: No magazines over 15 rounds. We are restricted from shipping magazines with a capacity exceeding 15 rounds to customers with a Colorado shipping and/or billing address.

CONNECTICUT CUSTOMERS: No magazines over 10 rounds. We are restricted from shipping magazines with a capacity exceeding 10 rounds to customers with a Connecticut shipping and/or billing address.

DELAWARE: No magazines over 17 rounds. We are restricted from shipping magazines with a capacity exceeding 17 rounds to customers with a Delaware shipping and/or billing address.

HAWAII CUSTOMERS: No magazines over 10 rounds. We are restricted from shipping magazines with a capacity exceeding 10 rounds to customers with a Hawaii shipping and/or billing address.

ILLINOIS CUSTOMERS: No magazines over 15 rounds. We are restricted from shipping magazines with a capacity exceeding 15 rounds to customers with an Illinois shipping and/or billing address.

Aurora: No magazines over 15 rounds.

Cook County: No magazines over 10 rounds.

Deerfield: No magazines over 10 rounds.

Dolton: No magazines over 10 rounds.

Evanston: No magazines over 15 rounds.

Highland Park: No magazines over 10 rounds.

Homewood: No magazines over 10 rounds.

Skokie: No magazines over 15 rounds.

MASSACHUSETTS CUSTOMERS: No magazines over 10 rounds, no shotgun magazines over 5 rounds. We are restricted from shipping magazines with a capacity exceeding 10 rounds to customers with a Massachusetts shipping and/or billing address.

MARYLAND CUSTOMERS: No magazines over 10 rounds. We are restricted from shipping magazines with a capacity exceeding 10 rounds to customers with a Maryland shipping and/or billing address.

NEW JERSEY CUSTOMERS: No magazines over 10 rounds. We are restricted from shipping magazines with a capacity exceeding 10 rounds to customers with a New Jersey shipping and/or billing address.

NEW YORK CUSTOMERS: No magazines over 10 rounds. We are restricted from shipping magazines with a capacity exceeding 10 rounds to customers with a New York shipping and/or billing address.

OREGON CUSTOMERS: No magazines over 10 rounds. We are restricted from shipping magazines with a capacity exceeding 10 rounds to customers with an Oregon shipping and/or billing address.

RHODE ISLAND CUSTOMERS: No magazines over 10 rounds. We are restricted from shipping magazines with a capacity exceeding 10 rounds to customers with a Rhode Island shipping and/or billing address.

VERMONT CUSTOMERS: No magazines over 15 rounds. We are restricted from shipping magazines with a capacity exceeding 15 rounds to customers with a Vermont shipping and/or billing address.

VIRGINIA CUSTOMERS: No magazines over 15 rounds. We are restricted from shipping magazines with a capacity exceeding 15 rounds to customers with a Vermont shipping and/or billing address.

WASHINGTON DC CUSTOMERS: No magazines over 10 rounds. We are restricted from shipping magazines with a capacity exceeding 10 rounds to customers with a Washington DC shipping and/or billing address.

WASHINGTON STATE CUSTOMERS: No magazines over 10 rounds. We are restricted from shipping magazines with a capacity exceeding 10 rounds to customers with a Washington shipping and/or billing address.
